Bryan advised that there are things that we can do to raise funds that would not require output from SE – like going to baseball games, etc. He advised that he can provide SE chair with ideas that other areas are doing. He also added that each group is autonomous, so they can donate their money as they wish.

Jeff asked if SE could provide an amount that SE spends on events, so homegroups can have a better idea of how much would be a good donation. Sam advised the prudent reserve is \$400, and the max of the account can be \$3000.

Mindy asked how long the \$400 reserve has been in place, as inflation/prices have increased significantly.

Dylan reiterated the need for area members to show up to events.

Carly asked if we could promote events more? Sam advised that they have done fliers previously. Billy added that events are not regularly announced at meetings.

Chris shared that when he was SE chair, they would hold dances and marathons. Sam advised that no one showed for the dance. Mindy stated that barely anyone showed to the marathon, and those that did were from Baltimore.
